### ABOUT WSIB SAFETY GROUPS

Safety Groups is a performance-based rebate program developed by the Ontario Workplace Safety and Insurance Board (WSIB). It offers participating firms the opportunity to receive rebates on their WSIB premiums if they can collectively improve their health and safety performance.

Firms must tackle five key elements of their safety program over the course of a year. Safety Group sponsors hold four meetings during the year, of which the firm must attend at least three. Successful performance by a Safety Group, as determined by a random WSIB validation audit, will result in a rebate of up to 6 per cent (of WSIB premiums). **Webinars:** The Northern Ontario Safety Group (NOSG) is organized to administer an occupational health and safety support system that provides qualified participating firms with sector-specific program development resources and assistance to enhance the internal responsibility system within each firm.

With a northern Ontario focus, NOSG provides a better reach to businesses in smaller northern communities, along with an enhanced occupational health and safety support and networking capacity. One way the Northern Ontario Safety Group achieves this goal is through the use of webinars. Each webinar is specifically designed to assist members in achieving key benchmarks of the Safety Group program.
